On the Delisting of Shares

Pursuant to the Law on Securities dated November 26, 2019;

Pursuant to the Law amending and supplementing a number of articles of the Law on Securities, the Law on Accounting, the Law on Independent Audit, the Law on State Budget, the Law on Management and Use of Public Assets, the Law on Tax Administration, the Law on Personal Income Tax, the Law on National Reserves, and the Law on Handling of Administrative Violations dated November 29, 2024;

Pursuant to Decree No. 155/2020/ND-CP dated December 31, 2020 of the Government detailing the implementation of a number of articles of the Law on Securities;

Pursuant to Decree No. 245/2025/ND-CP dated September 11, 2025 amending and supplementing a number of articles of Decree No. 155/2020/ND-CP;

Pursuant to the application dossier for delisting BCG shares submitted by Bamboo Capital Group Joint Stock Company;

Pursuant to the opinion of the Listing Committee;

Upon the recommendation of the Director of the Listing Management Department;

HEREBY DECIDES:

Article 1. Delisting of Shares of Bamboo Capital Group Joint Stock Company

- Security type: Common shares
- Stock code: **BCG**
- Par value: VND 10,000 per share
- Number of shares to be delisted: **880,210,644** shares (Eight hundred eighty million two hundred ten thousand six hundred forty-four shares)
- Total par value of shares to be delisted: **VND 8,802,106,440,000**
- Effective delisting date: July 15, 2026

- Reason for delisting: The listed organization falls under the cases of mandatory delisting as prescribed in Point i, Clause 1, Article 120 of Decree No. 155/2020/ND-CP, as amended and supplemented by Point a, Clause 47, Article 1 of Decree No. 245/2025/ND-CP.

Article 2. The last trading day of BCG shares on the Ho Chi Minh City Stock Exchange was October 9, 2025.

Article 3. This Decision shall take effect from the date of signing

Article 4. Bamboo Capital Group Joint Stock Company and the Directors of the Listing Management Department, Trading System Department, Market Information Department, and Trading Surveillance Department of the Ho Chi Minh City Stock Exchange shall be responsible for the implementation of this Decision.
