#### **PROPOSAL**

About: Selection of an Independent Auditor for the 2024 Financial Statements

## To: Shareholders of Bamboo Capital Group Joint Stock Company

- Pursuant to the Law on Enterprises No. 59/2020/QH14 dated June 17, 2022 of the National Assembly of the Socialist Republic of Vietnam;
- Pursuant to the Law on Securities No. 54/2019/QH14 dated November 26, 2019 of the National Assembly of the Socialist Republic of Vietnam;
- Pursuant to the Charter of Bamboo Capital Group Joint Stock Company (BCG) approved by the Annual General Meeting of Shareholders 2023 (AGM) on April 28, 2023 (amended and supplemented for the 20th time);

## 1. Proposal on critera for the selection of an independent auditor:

- A firm with a team of highly qualified and experienced auditors.
- There must be no conflict of interest when auditing the Company's financial statements.
- Reasonable audit fee, which is suitable according to the content, scope and progress of the audit.

#### 2. List of audit firms selected to submit to the General Meeting of Shareholders:

With the above criteria, the Board of Supervisors would like to propose 07 (seven) auditors to be included in the list to provide audit service for the fiscal year of 2024 of the Company, as follows:

- Southern Auditing and Accounting Financial Consultancy Service Company Limited (AASCS)
- A&C Auditing and Consulting Company Limited (A&C)
- Deloitte Vietnam Company Limited (Deloitte)
- Ernst & Young Vietnam Company Limited (E&Y)
- KPMG Company Limited (KPMG)
- PricewaterhouseCoopers Company Limited (PwC Vietnam)
- RSM Vietnam Auditing & Consulting Limited (RSM).

## 3. Opinions of the Board of Supervisors:

With the above proposals, the Board of Supervisors would like to submit to the General Meeting of Shareholders:

- Approve the criteria mentioned in Section 1 and the list of 07 independent auditing firms mentioned in Section 2. Accordingly, the Board of Supervisors will select an independent auditor to provide the audit and review services for the Company's financial statements for the fiscal year 2024.
- Approve the authorization for the Board of Directors to decide on the selection of an independent auditor, and assign the Chief Operating Officer to sign a contract with the selected audit firm, based on the selection criteria. This will ensure optimal benefits for the Company.
