- Pursuant to Enterprises Law No.68/2014/QH13 which was promulgated by the National Assembly on November 26th, 2014;
- Pursuant to Securities Law No.70/2006/QH11 which was adopted by the National Assembly on June 29th, 2006; Law No.62/2010/QH12 amending, supplementing a number of Articles of the Securities Law on November 24th, 2010 and guidance documents;

- Have no conflicts of interest when auditing the FSs for the Company;
- Have reasonable audit fee, suitable to the contents, scope and schedule of the audit.

2. Suggestion of independent auditing companies:

With the above-mentioned selection criteria, Board of Supervisors would like to suggest 06 (six) auditing companies to be included in the list of selected auditors who shall provide the services on auditing and reviewing the Company's FSs in fiscal year 2018. (in alphabetical order), as follows:

- Southern Auditing & Accounting Financial Consulting Services Company Limited (AASCS)
- A&C Auditing and Consulting Company Limited;
- AASCN Co., Ltd
- Grant Thornton (Vietnam) Limited
- KPMG Vietnam
- PricewaterhouseCoopers (Vietnam) Limited (PWC Vietnam)

3. Board of Supervisors' opinions:

With the above-mentioned suggestions, Board of Supervisors would like to submit to the General Meeting of Shareholders for:

- Approving the selection criteria mentioned in Section 1 and list of 06 independent auditing companies mentioned in Section 2 in order for Board of Supervisors to serve as the basis for selecting the provider of services in auditing and reviewing the Company's FSs in fiscal year 2018.
- Approving the authorization for Board of Directors to decide to select one of the auditing companies suggested above by Board of Supervisors and assign Chief Executive Officer to sign the agreement on provision of services on auditing and reviewing the FSs in fiscal year 2018 of Bamboo Capital JSC.
