- Audit cost is reasonable, adequate to the audit contents, scale and progress.

2. Proposal of independent audit companies:

With the above-mentioned criteria, the Supervisory Board would like to propose 06 (six) audit companies to be mentioned in the list of providers of audit and review services of the Company's FSs in the financial year 2017 (ranked in sequence ABC), as follows:

- AASCS Co., Ltd;
- A&C Auditing and Consulting Co., Ltd;
- CPA VIET NAM;
- Grant Thornton (Vietnam) Limited
- KPMG (Vietnam) Co., Ltd;
- PwC Viet Nam.

3. Supervisory Board's ideas:

With the above-mentioned proposals, the Supervisory Board would like to propose the General Meeting of Shareholders:

- Approve the selection criteria indicated in Section 1 and list of 06 Independent Audit Companies indicated in Section 2 so that the Supervisory Board shall base on them to select the provider of audit and review services of the Company's FSs in the financial year 2017.
- Approve the authorization granted to the Board of Directors to decide to select any of the audit companies which are proposed above by the Supervisory Board and assign the General Director to sign the contract on provision of audit and review services of the FSs in the financial year 2017 of Bamboo Capital Joint Stock Company.
